1. WOW members will be present at the 2026 Wishes on Wheels Truck Convoy Sunday Sep 27, 2026. WOW will provide you with a space from which to sell your goods from your food truck. You will get all required permits and licenses, including, but not limited to, a mobile food license. This event is held rain or shine. WOW does not provide booths, tents, tables, chairs, or canopies and is not liable for any damage, theft or weather conditions.
2. You will:
 - a) Submit this contract, along with a non-refundable participation fee, payable to Wishes on Wheels Inc your payment to Wishes on Wheels - ATTN Food Truck Vendor, P.O. Box 281145, East Hartford, CT 06128
 - b) Follow our rules and instructions, including, but not limited to filing a East Hartford Health District Temporary Food Service Form per East Hartford this must be filed online <https://easthartfordct.viewpointcloud.com/categories/1081>
 - c) PLEASE email Completed HEALTH DISTRICT PAPERWORK TO: Ron Apinis ron@wishesonwheels.com
 - d) Provide all food merchandise and sales staff necessary for your business.
 - e) Help WOW promote this event and your presence at this event by advertising your location through your social media sources;
 - f) Work from the space assigned to you by WOW, and be ready for business by the time specified on this contract; and Obey all laws.
3. You will return your assigned space in the same condition as when you arrived. Any damage to the space — including but not limited to staining from the operation of the food cart or truck — will be fully remedied at your expense.
4. WOW does not control who enters the food event. Any security we provide is for our sole benefit. You take all risk of loss or damage to your merchandise or other property, regardless of cause. You must obtain any insurance you want for your merchandise and/or other property. If your property is lost, stolen or damaged, you will not look to the organizers for payment. Organizers mean us, our volunteers and agents and/or WOW. In addition, vendor is **required** to have liability insurance naming **WOW as an additional insured**. This should include products (in case of food poisoning) and auto insurance (in case vehicle hits a guest).
5. You agree to take part in the "2026 Wishes on Wheels Convoy on the date of September 27, 2026. The participation deposit is a Deposit/donation, payable by August 31, 2026, by noon. If you cancel after this date, you are liable to Wishes on Wheels and the participation deposit will be for your donation. The event is rain or shine, no refunds will be given.

Food Truck Vendor Contract**

Food Truck Sales Policy:

WOW requires ALL vendors do not sell beverages other than those that are the Individual Vendors Primary Sales. No Sales of Soda, Juice and Water as WOW is provided these beverages and are made available for donation. WOW makes every attempt to review menus and verify that duplicate items are not sold by multiple vendors.

Weather Policy:

2026 Wishes on Wheels Truck Convoy is scheduled to take place Sunday, September 27, 2026. *The event will take place rain or shine.* Refunds will not be issued for inclement weather.

Fees:

Vendors participating in the 2026 Wishes on Wheels Truck Convoy must have their participation fee (\$200) and The East Hartford Health Department Documents Aug 31, 2026, at noon. The Health Department Application and fee is solely the Responsibility of the Vendor *Incomplete applications or applications without proper payments and documents will not be honored.*

Food Truck Vendor Fee:

20% of sale (honor system) to operate from 7 am 3 pm. You must be in your spot by 7:00 am Sunday, September 27, 2026

Health Inspections:

Prepared food vendors must provide Owner with a copy of their mobile food license. Vendors are expected to follow all rules and regulations as set forth by the East Hartford Health District. All vendors must comply with all East Hartford District Inspectors and their agents.

Promotions:

Vendors are encouraged to hold individual promotions as desired, which may include cross-promotion with other vendors.

Media Release:

By signing the Food Truck Vendor Contract and by participating in this event, you agree to the following statement:

"I hereby give my consent to all photographs, audio recordings, academic work and/or video recordings taken of me or my staff. I understand that any such photographs audio recording, academic work, and/or video recordings become the property of Owner and may be used by Owner, or others with their consent, for educational, instructional, or promotional purposes determined by Owner in broadcast and media formats now existing or created in the future."

Trash:

Trash receptacles will be placed throughout the area for Customer use. Vendors are expected to place their individual business's trash in the large dumpster's provided in the parking lot. Vendor is not to use communal trash receptacles for their trash removal. Failure by Vendor to remove their trash can result in a fine of \$200.

Indemnification:

Vendor agrees to indemnify, defend, and forever save and hold harmless Wishes on Wheels, its members or any organization working with them, and anyof its employees or agents, its affiliates or related entities, and their respective staff, shareholders, members, partners, officers, directors, employees, representatives, tenants, agents, contractors and volunteers, from and against any and all damages, claims, losses, demands, costs, expenses (including attorney's fees and costs), obligations, liens, liabilities, actions and causes of action, threatened or actual, which any one of the indemnities may suffer or incur arising from your acts or the breach of any agreement, obligation, warranty or representation made herein, or for claims not closely related to our duties under this Agreement, except to the extent such claims arise from our negligence or willful misconduct. The foregoing indemnification shall survive any termination or the expiration of the term of this agreement. Your indemnification does not extend to damages, claims, or losses occasioned by the acts of subcontractors of either your or our agents.
